The inherent risks include, but are not limited to, the propensity of equines to behave in ways such as running, bucking, biting, kicking, shying, stumbling, rearing, rearing, falling or stepping on that may result in an injury, harm or death to persons on or around them the unpredictability of equine's reaction to such thing as sounds, sudden movement and unfamiliar objects, persons or other animals; certain hazards such as surface and subsurface conditions; collisions with other animals; the limited availability of emergency medical care; and the potential of a participant to act in a negligent manner that may contribute to injury to the participant or there, such as failing to maintain control over the animal or not acting within such participant's ability.

In consideration therefore, for the privilege of riding and/or working around horses at the "Fun in the sun shows", the undersigned does hereby agree to hold harmless and indemnify "Fun in the sun shows", it's agents, managers, employees, landlords, officers, member, successors and assigns and further release them from any liability or responsibility for any accident, damage, injury or illness to the undersigned, any horse in which the undersigned has an interest as owner or otherwise, any family member or spectator accompanying the undersigned while on the premises of the property and that in the event of the show proven gross and willful negligence, undersigned shall bring no claims, demands, actions, and causes of action and/or litigation against the show for any economic or non-economic or non-economic losses due to bodily injury, death and/or property damage sustained by undersigned and/or undersigned's minor child (the parent/legal guardian acknowledges that by signing this agreement they are waiving claims on behalf of themselves and the minor child as well as their legal representatives, heir and assigns) in relation to the premises and riding, handling or otherwise being near horses.
